NOTICE OF PROHIBITION

WHEREAS on or about August 21, 2015, Douglas Ratcliffe ("Ratcliffe") was sentenced on the charge of Credit Union Theft, 18 U.S.C. § 657, a charge to which he had previously pleaded guilty, in connection with his employment at InTouch Credit Union, in the United States District Court for the District of Nevada;

WHEREAS a violation of 18 U.S.C. § 657 is a criminal offense involving dishonesty and breach of trust;

NOW, THEREFORE, YOU ARE HEREBY NOTIFIED THAT:

- 1. Pursuant to 12 U.S. C. § 1785(d)(1)(A) and 12 U.S.C. § 1829(a)(1)(A), Ratcliffe is prohibited from becoming an "institution affiliated party" of any insured depository institution, as defined in 12 U.S.C. § 1786(r); otherwise participating, directly or indirectly, in the conduct of the affairs of any insured depository institution; and owning or controlling, directly or indirectly, any insured depository institution;
- 2. Pursuant to 12 U.S. C. § 1785(d)(1)(B) and 12 U.S.C. § 1829(a)(1)(B), no insured depository institution may permit Ratcliffe to engage in any conduct or continue in any relationship prohibited in paragraph 1 above;

- 3. Pursuant to 12 U.S.C. § 1785(d)(3) and 12 U.S.C. § 1829(b), whoever knowingly violates paragraph 1 or 2 above is subject to a fine of not more than \$1 million for each day such prohibition is violated, or imprisonment for not more than five (5) years, or both:
- The "Judgment in a Criminal Case" document, Case No. 2:14-cr-00386-KJD-4. CWH-1, is made a part hereof and is incorporated herein by reference; and
- This Notice of Prohibition shall be effective and enforceable on the date set forth 5. below.

- 8) the defendant shall not frequent places where controlled substances are illegally sold, used, distributed, or administered;
- 9) the defendant shall not associate with any persons engaged in criminal activity and shall not associate with any person convicted of a felony, unless granted permission to do so by the probation officer;
- 10) the defendant shall permit a probation officer to visit him or her at any time at home or elsewhere and shall permit confiscation of any contraband observed in plain view of the probation officer;
- 11) the defendant shall notify the probation officer within seventy-two hours of being arrested or questioned by a law enforcement officer;

- 4. Access to Financial Information You shall provide the probation officer access to any requested financial information, including personal income tax returns, authorization for release of credit information, and any other business financial information in which you have a control or interest.
- 5. Pay outstanding monetary restitution imposed.
- 6. Employment Restriction You shall be restricted from engaging in employment, consulting, or any association with any business in a fiduciary capacity during the term of supervision.
- 7. FDIC and Credit Union Prohibition You shall not be employed by or have any association with any Federal Deposit Insurance Corporation Financial Institution or credit union as mandated by 12 U.S.C. § 1785 and 1829.
- 8. Warrantless Search You shall submit your person, property, residence, place of business and vehicle under your control to a search, conducted by the United States probation officer or any authorized person under the immediate and personal supervision of the probation officer, at a reasonable time and in a reasonable manner, based upon reasonable suspicion of contraband or evidence of a violation of a condition of supervision; failure to submit to a search may be grounds for revocation; the defendant shall inform any other residents that the premises may be subject to a search pursuant to this condition.
- 9. Possession of Weapons You shall not possess, have under your control, or have access to any firearm, explosive device, or other dangerous weapons, as defined by federal, state, or local law.
- 10. Report to Probation Officer After Release from Custody You shall report, in person, to the probation office in the district to which you are released within 72 hours of discharge from custody.


